- Welcome Marlin Horst who is now Chair of the Interlakes Group thanked the many members who attended today's meeting. His remarks included an update of our request for MNRF approval to stock lake trout from our local fish hatchery. He reminded us that our main goal is to protect Baptiste Lake, including its fishery.
- Mayor Tony Fitzgerald: Our mayor gave a thoughtful and straight forward address to the audience. His overriding message was that HH tax revenue is limited yet so many priorities need attention. The new Council is determining the Towns direction while dealing with staff turnover, rising costs and critical projects. He reminded us that our local government must work with numerous partners and deal with the county and province. He asked that we all be good neighbours and work together and voice our opinions in a thoughtful and productive manner. He also noted that we do not own the lake that we share it! The mayor suggested residents write to council members regarding concerns and offer constructive criticism with an offer to be a part of the solution.
- has a Masters in Environmental Control and Assessments. He has been instrumental in representing Baptiste Lake at monthly MNRF meetings, is securing funds through Watersheds Canada to improve our spawning beds and is our representative at the fish hatchery. Fred's message to us was to be aware of invasive species and the many causes of water quality deterioration. Wollaston has so much milfoil growth it has squeezed boat access which needed passages to be cut to allow boats to get through. His message: Education and Observation is Power.
