Minutes of Annual Meeting - Aug. 6/66.

The Annual meeting of the Baptists Cottages and Resort Owners Association was held on Saturday, August 6 - 1966, at 2.00 p. m., in the Parish Hall of St. Matthews United Church. Mr. Murphy, President called the

meeting to order and after a few words of welcome to the approximate 40 members present, asked each one to stand and identify themselves.

The District Forester, - Mr. R. D. Patrick from the Dept. of Lands and Forests was in attendance.

* Re - Water Level - Mr. Murphy read several letters dealing with maintenance of satisfactory water level in Baptiste Lake that have passed between him and the Department of Lands and Forests and the Bancroft Power Officials. Despite Mr. Murphy's efforts in our behalf the water level is still extremely low.

It was felt that a new and more forceful letter be written and published in the Bancroft Times, so that the officials and townspeople of Bancroft could see that the cottage owners of the Baptiste Lake area were very concerned over the situation and were anxious to have something concrete done about it NOW. Such a letter was read by Mr. Murphy.

Motion: By Mr. Ross that we revise and approve letter, (as read by Mr. Murphy) to Bancroft P.W.C. requesting that action be taken immediately to stabilize water level and to have said letter published in Bancroft Times for the benefit of the people of Bancroft.

Seconded - Mr. Mc Brien - Carried.

Discussion following aforesaid motion.

Mr. Morawetz thought the letter a good idea but would ask that any tone of a threatening nature be omitted.

Mr. House agrees with letter in part, but he too believes in omitting threatening

Mr. Ten Maasch also agreed that something should be done and done soon.

Mr. Patrick - District Forester referred to correspondence in his file concerning the reconstruction of dam with better control over water-level. The water level should be maintained between 15' and 16', and still respect the rights of Bancroft P.U.C., and others on the waterways.

Mr. Patrick quoted from file.

1912 - "The normal flow of the York River to be accorded to Bancroft P.U.C."

1931 - Hydro be permitted a 3' draw down for power purposes.

Motion: Mr. Canning moves that an amendment be made to Mr. Ross motion - re letter to Bancroft P.U.C., to the effect that the letter be revised and reconstructed to clearly state the members views, yet omit any threatening attitude on part of Baptiste Cottagers Association, and to have it published in the Bancroft Times. Seconded - Mr. Rijmicks -

Mr. Patrick offers to arrange meeting between Bancroft P.U.C. officials, members concerned with business of Cottagers Association, and Department of Lands and Forests.

Correspondence between Mr. Delingne and Mr. Murphy, re water level was read by Mr. Murphy.

Mr. Hourse requests that we find out just what our rights as Cottagers are legally before we negotiate our problems with Dept. of Lands and Forests and Bancroft P.U.C.

Mr. Peener spoke briefly about the first dam in 1866 being constructed solely for the purpose of the lumbering industry. ~~See 1750~~

Mr. Murphy read, in part a letter from Mr. R. J. Coode - Surveyor General received last April 6/66, with regard to elevation of water

Motion: By Mr. House that we accept Mr. Patrick's proposal for meeting and also to engage legal aid beforehand to find out Cottages rights, so as to be able to negotiate a suitable agreement between Bancroft P.U.C., Cottages Association and Department of Lands and Forests.

Seconded - Mr. Morawetz. - Carried

Mr. Ross withdraws his motion in favour of motion made by Mr. House.

Mr. Patrick introduces Mr. Goodman - Chief Ranger in Bancroft.

It was revealed Mr. Goodman must take orders from District Forester. Removal and replacing of logs at dam is advised by a representative of P.U.C., and work is done accordingly.

Those selected to represent Cottages at meeting are Mr. Murphy, Mr. Biggs & Mr. Willson.

(*) Mr. Peemer (Reeve of Herschel Twp) is also expected to attend.

Mr. Ken Loftus (representing Mr. Rydes) spoke of the biological survey and research programme now underway with regard to the wall-eye population in the lake.

Mr. Dick Rydes is in charge of survey, but was not able to be at meeting, due to a previous commitment.

In the spring and fall, Mr. Rydes and his team make surveys of the fish habits

have been tagged. Approximately 140 of these tagged fish have been caught and tags returned. Mr. Loftus entered into discussion with various members about the large numbers of rock bass in the lake. Mr. Canning stated that rock bass are eating the Maskinonge fry and fingerlings that the Department of Lands and Forests have stocked in the lake and has proof of this because of finding the fry inside opened rock bass.

This statement was corroborated by other members who had done the same.

Mr. Loftus did not have any figures or information at hand, but it was revealed that Baptiste Lake is not considered by the Dept. of Lands and Forests as a good rearing ground for Maskinonge.

Mr. Patrick suggested that a series of hoop nets, such as are used in the Trent River system, for eliminating unwanted fish may be a partial solution to reducing the number of rock bass in Baptiste Lake.

Mr. Patrick and other members from the Dept. of Lands and Forests left meeting to return to Tweed.

Motion: Mr. Canning moves that the minutes of the last annual meeting held Aug. 14/65, be accepted as read.
