3. **President's report** – Wally McColl

Successes: Thanks to the directors for the continuation of programs such as the lake shore restoration in conjunction with the BASC, the Lake Trout project in conjunction with the MNRF and the newsletter to name a few. Also, he appreciates the directors' work in decision making during the troubled COVID times. Thanks to Adrian Hill for stepping up as President in the past few weeks.

Wally presented his intent to resign as of today. He hopes that the BLA has influence in matters concerning the health of the lake even though we don't have authority. He questioned the fireworks by-law passed this summer.

There was no recognition by the H.H. council of the letters sent to the municipality by BLA members and the president.

Marlin Horst has agreed to step in as president for the next year.

Carried Questions asked by Bill Cheshire regarding the fact that assets are twice the operating expenses were fielded by Eric Hooey and Adrian Hill who replied that we are maintaining a prudent reserve of a 2 year operating ability and offering donations to the community where needed.

Lake Partner program governing water quality, supported by Provincial Government, the Provincial Government has renewed the program up to 2025
