Baptiste Lake Association AGM Minutes

- 1. Welcome Marlin Horst The meeting started at 10:05.
- Mayor Tony Fitzgerald to spoke about the Achievements of Hastings Highlands in the past year and the challenges.

He found it gratifying to be speaking at Birch Cliff, where he worked summers as a student, taught in Bancroft for several decades. He addressed that the Capital Budget passed at \$5.2 million, South Baptiste Lake Road is repaved and 1.8 million went to that job. There has been a gravel road solution for Maxwell Settlement. Raised taxes to put \$1.2 million back into reserves (had to take out 4.2) 420,000 for 2 trucks, the culvert on North Baptiste will cost around \$400,000. Cuts continue from the Provincial Government. The federal government must become included in the funding. In April, Tony had a meeting with the Minister of Transportation, to discuss the cost of \$30,000,000 to resurface the road from Combemere to Maynooth. Positive meeting. Created a relationship with the minister, which aided in solving a serious problem along Hwy. 62 where there is bridge work hindering traffic. Strategic Plan, second revamp, available online through the website. Tony spoke about the cell towers, 7 towers coming to the municipality. Also a provincial housing project is pending but the monies released went to large cities such as Ottawa, Hamilton and Guelph. He also alluded to the Fire Department plan, a 3-station format. Future projects include looking at removing certain fire station properties that are costing too much and are standing empty. Salary negotiations are concluding and of course, raised salaries will again add to the deficits. \$10,000,000 must be added to the reserves for 15 years in order for the maintenance of the municipality to be safe.

A question about septic inspections was raised, as well as control of signs and lastly, roadside pickup garbage. Recycle cost \$300,000. Cost to close a dump = \$1 million. Septic inspections must be uniform, all lakes and each property must be inspected. One beginning step could be to disseminate information through the BLA. Would like to start one lake at a time, make the septic inspection voluntary. Perhaps to issue a certificate per each tank pump out, which would cover about 75% of the properties. The Septic companies could issue the information to help the municipality. Another question raised, "How much of our tax money stays in the Municipality?" Less than 70% stays in the Municipality. OPP costs are offloaded to the municipality.

3. President's Comments and Introduce Directors – Marlin Horst

Overview of the events: Well attended corn roast last year and we hope that this year's will be equally successful, our opening event was great, the canoe/kayak day was pleasant including a barbecue at Colemans, we are working on support for the fishery, because fish population health indicates the health of the lake. The Watersheds Canada organization is so supportive for the lake. Will be cleaning the fish spawning areas this fall.

Monitoring development on the lake. We are a cold-water Trout Lake. We need to keep this designation to prevent crown land from being developed.

Marlin is chairman for the Interlakes Group. Plea for having volunteers on the Septic re-inspection. Land Use Committee review group works with the Variance Committee. The Interlakes Group is not recognized by the staff of Hastings Highlands. Information about the repair of the Dam. Should have started the work by August 12. The rainfall recently has changed the conditions temporarily. Communication with the MNRF is ongoing and transparent.
